Booth Guidelines:

- Booths must be decorated for Halloween. All booth decorations and table are your responsibility. Each booth space is 10 feet by 10 feet.
- Booths must be set up and ready by 6:00PM and be staffed for the duration of the event. We will start wrapping up the trail trick or treating by 8:30pm.
- This is a family-friendly event geared toward children ages 12 and younger. All decorations, giveaways, and costumes must be appropriate for children
